party and/or his insurers on such terms as you deem fit. Upon settlement of my/our claim, you are
authorised to sign any Discharge Voucher or any document to confirm my acceptance of the
settlement as full and final discharge of my/our claim, on my/our behalf. You also have my/our
full authority to collect all compensation monies pertaining to the above-mentioned accident from
insurance company or any other party, directly to your workshop M/s

RENTAL AGREEMENT

The Rental Agreement is made between
SENTOSA LIMOUSINE SERVICES PTE LTD (201500705W)
(herein referred to as "the owner") and

the person signing the Rental Document (herein referred to as "the hirer")
It is hereby agreed as follows:

VEHICLE DESCRIPTION AND TERM OF HIRE

1. The owner will let and the hirer will take the motor vehicle,

Registration Number SFD5848H

Car make/model BMW 318I

PERIOD OF LEASE

From 19 Jun 2019, if the end period is not specified, the hirer must lease for
at least 6 months, failing which the hirer is liable for a penalty of \$3000 on
top of other payable stated in this agreement.

The hirer can terminate by giving one week advance notice after the minimum period.

PERSONS WHO MAY DRIVE THE RENTAL VEHICLE

2. The vehicle may be driven during the term of hire only by the persons named on
this Rental Document, and only if they hold a current full valid driver's licence which
is not under any suspension, appropriate for this vehicle.

PAYMENTS BY HIRER

3. The hirer shall pay the owner for the hire of the vehicle,

\$ 430 weekly as rental payment for the car.

\$ weeklv for the 1st — week as deposit which will be refundable
within 5 weeks upon return of the car provided you settle all outstanding
payment owe to us immediately and there is no breach of contract.

All these payment will be deducted from your weekly Uber payment, if there
is any shortfall, you are to pay the difference immediately.

Upon end of contract and returning of car, if there is any outstanding balance
the driver have to return all the previous uber payment made to the driver
account.

4. In addition to the payment specified in clause 3 above, the hirer acknowledges that
they shall be liable at the end of the hire term to pay to the owner any applicable
additional charges payable at the end of the term. These include, but are not limited to:

- a) charges for late return of the vehicle;
- b) charges for damage to or repair of the vehicle, and any enforcement charges
relating to such damage or repairs (including legal costs);
- c) charges for cleaning the vehicle's interior if the vehicle is returned in an excessively
dirty condition that requires extra cleaning or deodorizing. This includes, but is not
limited to, spillage of fluids, food, vomit, other stains, and unpleasant odours
including cigarette smoke;
- d) traffic and/or parking offence infringement fees.
