**Brief Details.**

On 05/11/2019 at about 1920hrs, I was driving my car bearing the registration of SGJ5104R along Bukit Timah Road towards to Bukit Tinggi Road.

On the same day at about 1930hrs, I was nearing the junction of Bukit Timah Road and Swiss Club Road. I was hesitating whether to turn right as I am unsure of the road. At the last minute, I made the turn. While turning, I saw my car is nearing the center divider, I tried to stop but not able to do so. So the front of my car collided with the center divider.
