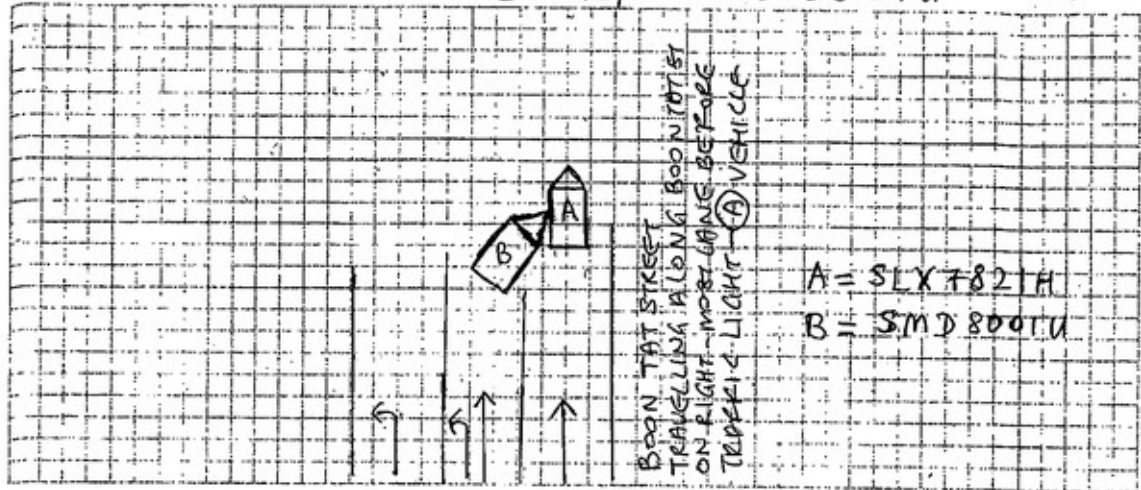

CONTINUATION OF REPORT

**Brief Details.**

On 11th January 2018 at about 6.42pm, I was approaching a Traffic Light on the right-most lane (Lane 1) located on Boon Tat Street that was indicating Red. I passed 2 cars which has stopped on the center lane (Lane 2) at a very slow speed when the Traffic Light turned green. Just before I started to accelerate off, I heard a scratching sound on the rear-left side of my car (SLX7821H). I continued forward before stopping my car and turning on the Hazard Light. This was when I noticed that a white car (SMD8001U) passed me on my left and stopped diagonally in front of me before the driver looked at me for about 30 seconds before it moved off. I noticed that there were scratches on the front-right side of the car. The said driver did not alight from his car to exchange particulars with me. I managed to record down the Vehicle Registration Number of the said car onto my mobile phone before the said car moved off.

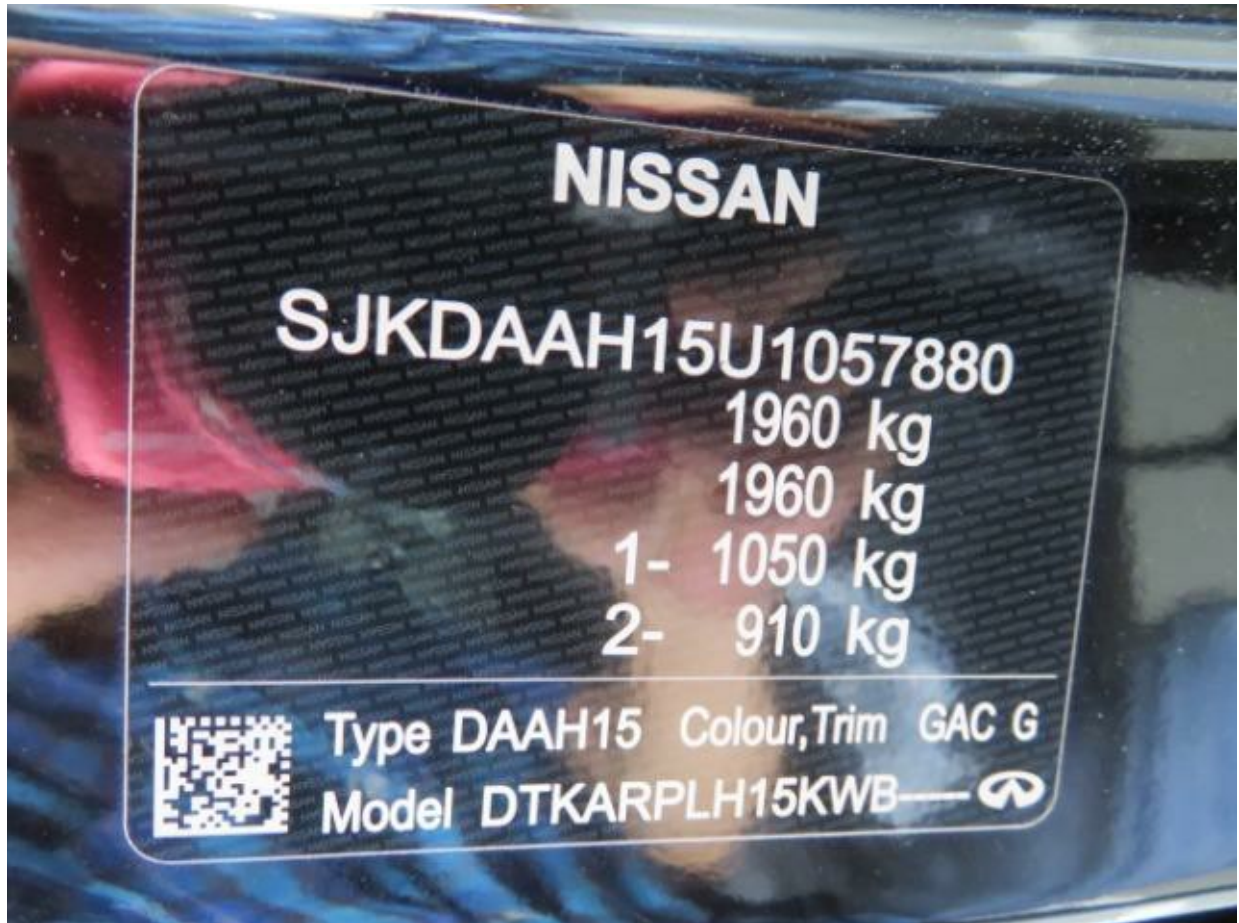
