## LETTER OF AUTHORITY & INDEMNITY

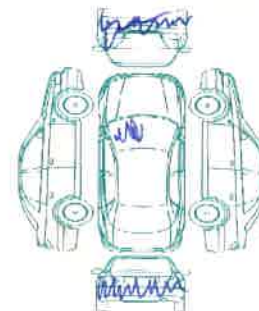
