 - (v) complying with applicable law in administering, processing, handling and/or dealing with my claims (collectively the "Purposes")

 - (ii) for complying with requirements under any regulations, laws or court orders.



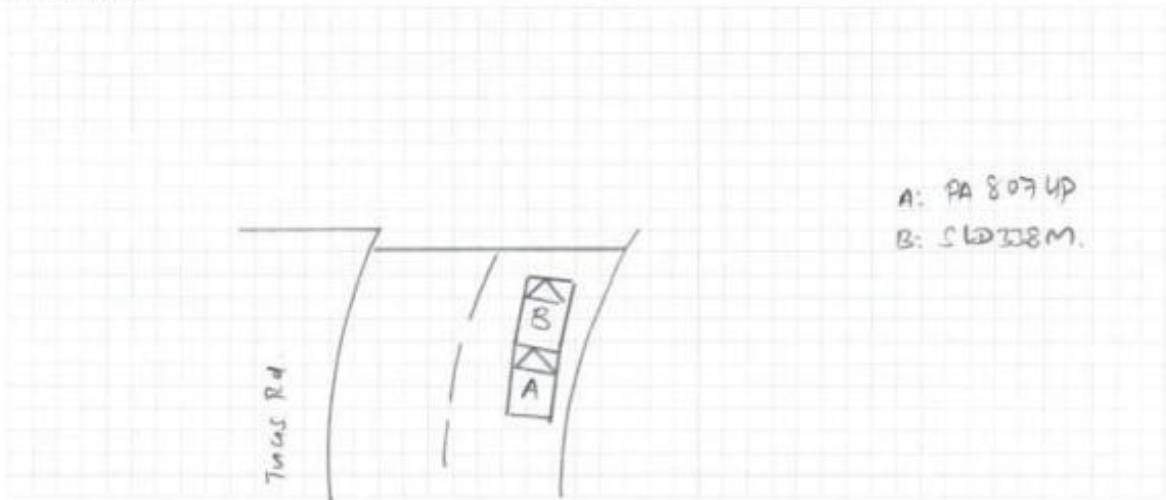
