**Brief Details.**

On 06/11/2019 at about 1230hrs, I parked my vehicle bearing plate number SLF3338H at a parking lot located at Dempsey Hill open space carpark. I am unable to recall the parking lot number at this moment.

I then left the vehicle and headed to attend to other personal activities.

Subsequently on the same day, I returned to my vehicle at about 1430hrs and found a paper left behind on my vehicle's front windscreen. Written on said paper was "Fyi, SLD711T knock on your car, check behind". There was no name or contact details written on the paper, and I do not know who had left this piece of paper on my windscreen.

I proceeded to make a check at the rear of my vehicle and discovered that there were some scratches on the rear of my car boot, causing the paint to be scrapped off.
