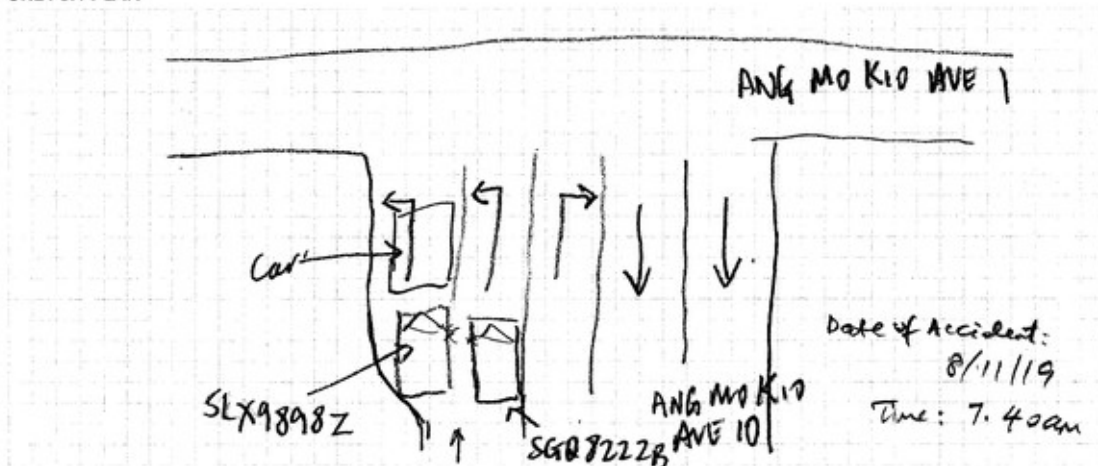

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling along Ang Mo Kio Ave 10 towards Ang Mo Kio Ave 1. Near the T-Junction, the road open up from ~~one~~ ^{two} lanes to three lanes. One lane is for turning right and two lanes for turning left. The vehicle SLX9898Z was at the extreme left lane stationary wanting to turn left to Ang Mo Kio Ave 1. The adjacent lane was empty and I filter slowly from behind him to the empty lane. At about 7.40am on 8 Nov 19, my left wing mirror brushes against his right wing mirror. Both of us stopped along Ave 1 to inspect the damage. Both my wing mirror and his wing mirror has slight scratches. His right side mirror is able to open and close properly. The only damage is a slight scratches on the side of his mirror. My mirror sustained scratches and a small crack on the right.

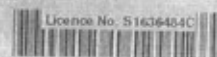
