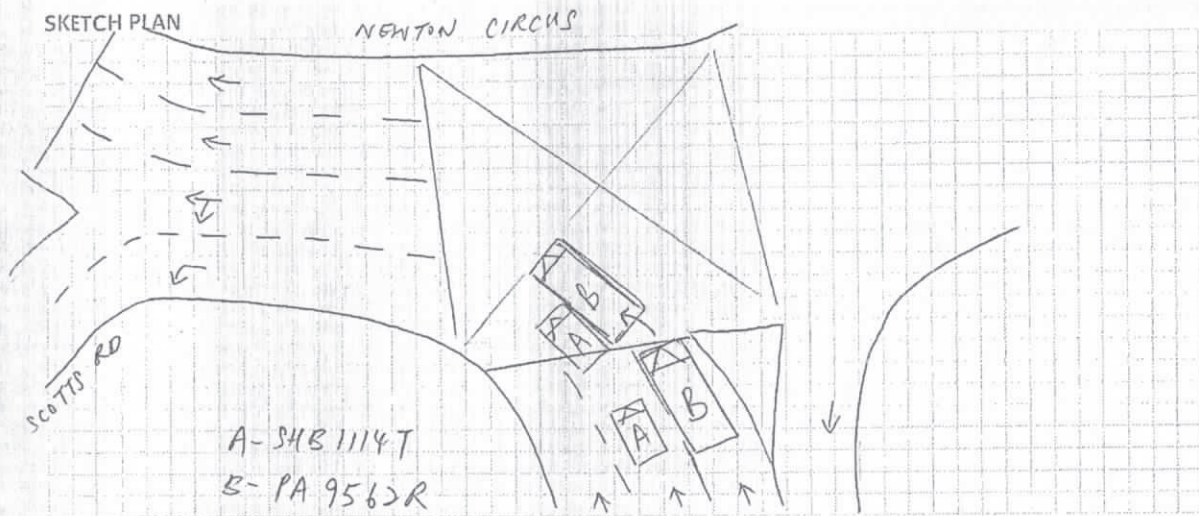

 - (v) complying with applicable law in administering, processing, handling and/or dealing with my claims.(collectively the "Purposes")
