While my bus SMB140P was travelling along the left most lane at Eunus link junction with Kaki Bukit Ave 2. 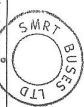

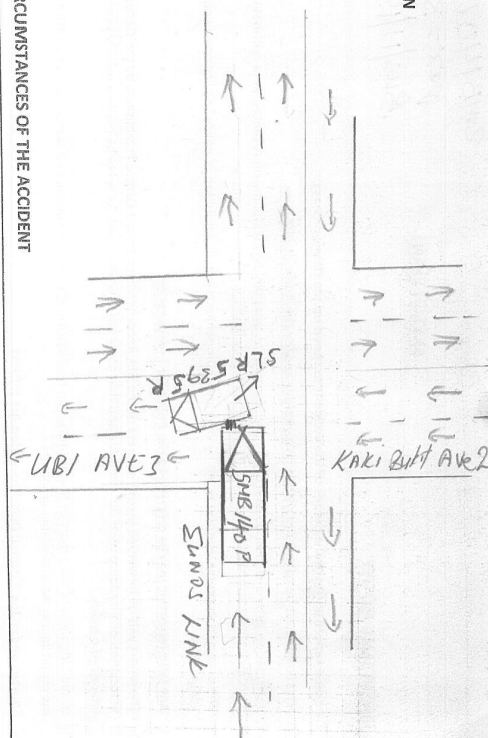
