
8. Consent under the Personal Data Protection Act (PDPA)



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Was driving in SHE 5730C along Tampines Ave 7 to get to Tampines Ave 9. As I approach the junction connecting Tampines Central 7 and Tampines Ave 7, the A taxi SHC 2178Y, a blue compact Hyundai taxi, suddenly moved out from its stationary position to turn left into Tampines Ave 7 from Tampines Central 7.

My car was moving straight on the left lane and was not changing lanes at the point of accident. The taxi was visible and clearly seen to be stationary when I approached the traffic light (which was ^{showing} green).

The taxi knocked the left side of my car, ~~damaging~~ ~~causing~~ it to go ~~into~~ ~~the~~ ~~left~~ ~~lane~~. Damage can be seen on the 2 left passenger doors and the rear left wheel.

Taxi was ferrying 4 passengers at that time while my car had 2 other passengers. No injuries noted to both drivers and all passengers.
