a) Case IAFP-IB-20191115 - Mechanical Inspection of Motor Car, SLL2103T (TP/IP/70391/2019)

On 12 November 2019 (Tuesday) sometime before 3.29 p.m, the Accused was driving a motor car, SLL 2103T, exiting a car park gantry of Blk 288A Jurong East Street 21. When she exited the car park gantry, the Accused made a right turn heading towards the main road of Jurong East Street 21. While the Accused was in the midst of turning right, the Accused's frontal portion of the motor car collided onto the Deceased who was walking across the service road of Blk 288A Jurong East Street 21 from Accused right to left view. Upon impact, the Accused front right wheel ran over the Deceased. As a result of the accident, the Deceased sustained serious head and chest injuries.
