Dear Lay Ghim and Agnes,

We refer to the conversation with our Mr. Lau earlier.

On our market value (MV) computation of \$76K, kindly refer to the references we have enclosed for your perusal.

As owner's vehicle is the less common model of the BMW M3, there were only a handful of references on SG Carmart.

In the three references we have enclosed, the transacted prices are generally higher than our quoted MV despite the condition of these vehicles (a) all higher number of ownerships as compared to owner's (only second ownership), (b) higher mileage as compared to owner (owner's mileage was at 72,367km).

In other words, the MV of \$76K quoted for owner is already pegged down in comparison.

Till date, we have only given instruction to repairer on one occasion (email on 4 December) that our insurer's mandate i.e. authorization to repair is for <u>not exceeding a repair limit of \$20,000 (lump sum)</u>, or whichever lower. At this point, repairer is requesting for \$27,000, from the previous requests of \$32,000, and \$29,000 (lump sum basis for all).
