REFER TO POLICE REPORT NO. T/20170619/2144 :- ON 19/06/17, AT ABOUT 1510HRS, I WAS DRIVING MY VEHICLE "GBB7630B" AND WAS EXITING OUT THE LOADING AND UNLOADING BAY OF THE CARPARK OF BEDOK MALL. AS I WAS EXITING THE AREA, THERE IS ANOTHER VEHICLE (LORRY) WHO IS ENTERING THE LOADING AND UNLOADING BAY ON MY RIGHT SIDE AND THE BACK DOOR OF THE CONTAINER OF THE OTHER VEHICLE CAME OUT AND THE WHOLE DOOR FELL ON HIT THE FRONT RIGHT SIDE OF MY VEHICLE'S BUMPER. THERE IS A SLIGHT DENT AND SOME OF THE PAINT AT THAT AREA WAS CHIPPED OFF. I WOULD LIKE TO STATE THAT I DO NOT HAVE THE DRIVER'S PARTICULARS BUT THE REGISTRATION PLATE OF THE OTHER LORRY IS "GZ1445Z", JUST THE NAME OF THE OTHER DRIVER'S COMPANY (DILIC INTERNATIONAL PTE LTD).

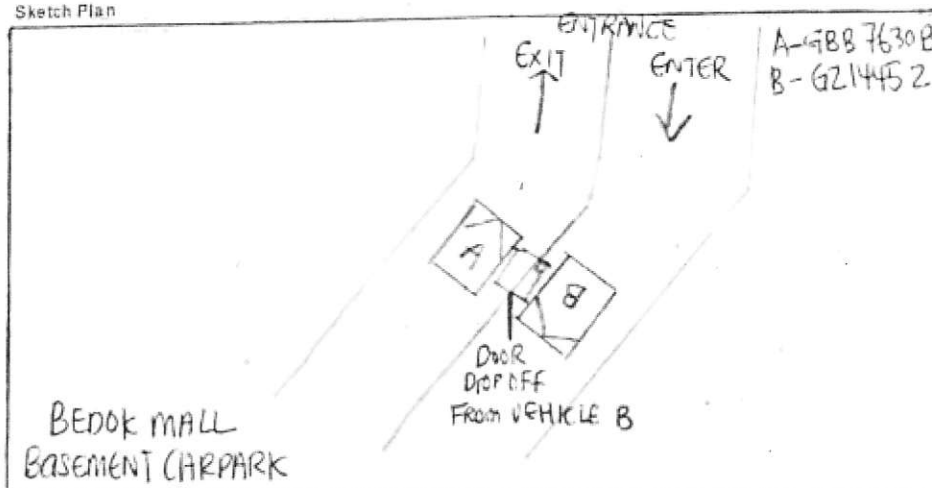
