Brief Details.

On 10/11/2019 at 2045hrs, I was driving along Geylang Road just beside Lor 12 Geylang on the 2nd lane from the left travelling towards the direction of Kallang Road. I noticed a white van bearing vehicle registration number GBH4356G approximately half a car length ahead of me on my right, signaling left. I felt that he was dangerously close and as such, I honked at him once to alert him that I was there, the said van then slowed down and changed to the lane behind me and subsequently overtook my car from the left most lane and immediately steered in front of my car and jammed his brakes. I managed to stop my car and a dispute occurred. I took several photos of the vehicle which happened to be a company vehicle belonging to www.sgpaclogistics.com. The driver of the van then accused me of hitting onto his vehicle. The driver of the van then went into his vehicle, purposefully reversed into the front portion of my car and drove off. I decided to call for police assistance. The man left before police arrived. I was then provided with a case card with reference number G/20191110/0191 and was told to lodge a traffic accident report. A further check was made on the company's website and I noticed someone that looked like the driver of the van as he was also wearing a cap and had a full sleeve arm tattoo. That is all.
