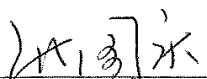
**SKETCH PLAN**

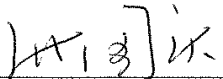

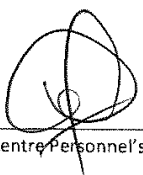

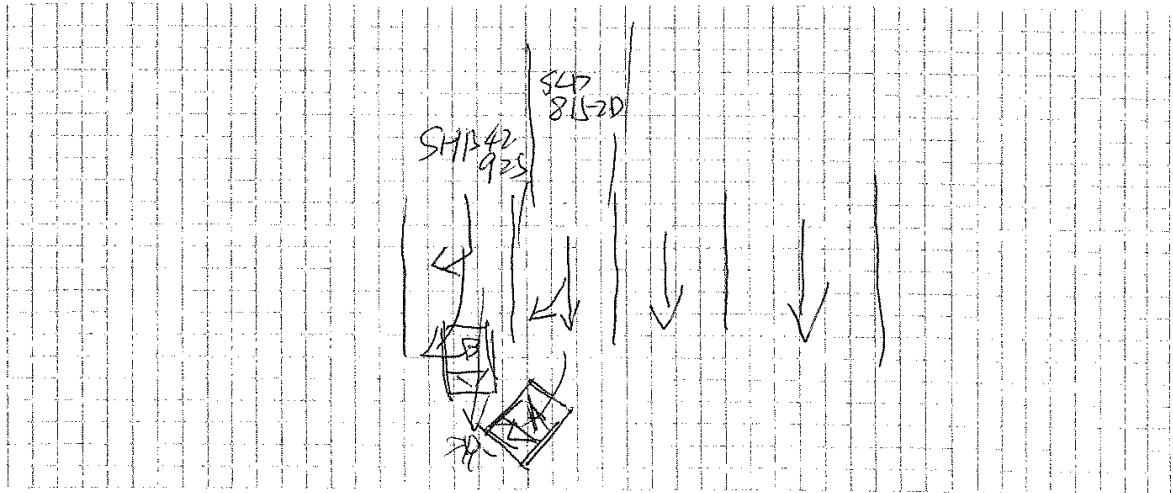
