DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On the above said date & time, I was driving my vehicle A (GBE 6578K) traveling along PIE tuds TWS on second lane of a 4-lanes, expressway. Somewhere before Jalan Eunos Exit, vehicle D (SMP6566G) ahead slowed down and stopped due to the heavy traffic flow. As such, I applied brake and stopped completely behind vehicle D. Out of sudden, vehicle B (SLW8673S) came from the rear and collided directly onto the rear portion of my vehicle. Upon the impact, my vehicle surged forward and collided onto the rear portion of vehicle D. After the accident, I alighted and realised that I was involved in a chain accident of 4 vehicles. There was the first vehicle C (SFX9955M) in front.
