May I seek your assistance to perform a detailed mechanical inspection of the <u>14 vehicles</u> below: [The ones marked in RED are deemed to be URGENT hence please EXPEDITE ON THESE REQUESTS]

a) Case IAFP-IB-20191112 - Mechanical Inspection of Motorcycle, DDG531 (TP/IP/68527/2019)

b) Case IAFP-IB-20191112 - Mechanical Inspection of Motor Trailer, XB6778E / TRC3584H (TP/IP/68527/2019)

On 5 November 2019, Tuesday at about 2034hrs, the motor trailer was travelling along SLE (BKE) 3.36km on lane 4 of the 4-lanes road. A bystander witness informed that he noticed the motor trailer made a right lane changed from lane 4 to lane 3 and side-swiped onto the motorcyclist that was travelling along lane 3. The impact point was believed to be at the rear chassis of the motor trailer. Due to the impact, the motorcyclist was unconscious thus he was conveyed by an ambulance to Khoo Teck Puat Hospital and is currently admitted in ICU.

On 10 November 2019, Sunday at about 0731hrs, the motor bus had exited from a bus stop and had merged onto the right of 2 lanes. There was a signalized pedestrian crossing ahead and thus he applied brakes to slow down. The driver claimed that he depressed his brake pedal 3 times but it did not work thus he veered to the right and collided onto the centre guard railings. 8 portions of centre guard rail was uprooted.

On 05 November 2019, Tuesday sometime before 1051 a.m., the accused was driving his motor car on lane 1 of 4-lanes along Bt Batok Road and had made a u-turn at the opening in the centre median near to lamp post 150 when the deceased's motorcycle proceeded straight from the opposite direction on lane 1 and collided onto the left side of the accused's motorcar. Deceased waswas pronounced dead at the scene at 11.05am.

On 05 November 2019, Tuesday sometime before 1054 a.m., the accused was driving his motor car on lane 1 of 4-lanes along Lentor Avenue towards Ang Mo Kio Avenue 6 when he collided onto the pedestrian who was crossing the road from his right to left at the Pedestrian Crossing near the junction of Yio Chu Kang Crescent. Pedestrian was conveyed to KTPH where she succumbed to her injuries and was pronounced dead on the same day at 12.17pm.

On 29 October 2019, Tuesday sometime before 10.11 a.m., the accused was driving the said motorbus along Yishun Avenue 5 and had made a right turn into Yishun Avenue 2 when he collided onto the Deceased(pedestrian) who was crossing the road at the pedestrian crossing from his right to the left. Deceased sustained head and other injuries and was conveyed by AB to KTPH. He subsequently succumbed to his injuries and was pronouced dead at KTPH on the 30 October at 225 p.m.

i) Case IAFP-IB-20191112 - Mechanical Inspection of Motorcar, SJC6575J (TP/IP/57819/2019)

On 13 September 2019, Friday at about 10:55 a.m., (B1) SJC6575J was travelling along Punggol Road towards Hougang Avenue 10, a single lane slip road into Rivervale Drive towards Sengkang East Avenue, where B1 was following behind 2 unknown motorcars which had stopped at the pedestrian zebra crossing. When the 1st unknown motorcar move off, the 2nd unknown motorcar and B1 follow suit. When B1 was about to drive onto the zebra crossing, (B2) E-scooter 562DP was seen riding from the pedestrian island (on B1's right) towards the zebra crossing, where B2 did not stop and rode onto the zebra crossing. B1's front right portion then collided onto B2's left, where B2's head hit onto B1's front right windshield and fell onto the ground. Due to the accident, B2 was conveyed to KTPH by the SCDF ambulance in an unconscious state. B2 is still in coma, as she sustained head injury and is currently warded for monitoring.

j) Case IAFP-IB-20191112 - Mechanical Inspection of Motor Car, SKG5864Z (TP/IP/66093/2019)

On 23 October 2019 sometime before 4.04 p.m., the accused was driving his motor car on lane 1 of 4-lanes road along Sims Ave towards Sims Ave East and subsequently made a right turn into Lorong 15 Geylang. While he was doing so, the frontal right portion had collided into the right portion of a pedestrian (deceased) who was still crossing ahead of the said motor car from the driver's left side to right side. Due to the accident, pedestrian sustained head injury thus she was conveyed by an ambulance to Tan Tock Seng Hospital. However on 24 October 2019 at about 5.52 a.m., the pedestrian succumbed to her injuries and was pronounced dead 5.52am by Dr Felicia Tan Su-Yen in Tan Tock Seng Hospital.

I) Case IAFP-IB-20191112 - Mechanical Inspection of Tipper Truck, XE1531S (TP/IP/67665/2019)

On 2 November 2019 (Saturday) at about 8.18 a.m., based on the account of the Witness, the Deceased was travelling along the exit of Woodlands Avenue 2 from SLE (CTE), directly behind the Involved Party's motor lorry. The Witness claimed that the Deceased had swerved to his right side and was believed to be trying to overtake the Involved Party's motor lorry from the right side. As the Deceased was approaching the right rear side of the Involved Party's motor lorry, the left side of the Deceased's motorcycle side-swiped the right rear side of the motor lorry. Due to the impact, the Deceased skidded together with his motorcycle and landed behind the motor lorry. The Witness was unsure if the Deceased was run over by the Involved Party's motor lorry but confirmed that the Involved Party was within his lane and did not veer left or right before the collision occurred. Due to the accident, the Deceased sustained multiple injuries and was pronounced dead at the scene by the attending Paramedic Nur Azhar at 8.30 a.m.

On 7 November 2019, Thursday at about 1.40 p.m., the Involved Party's tipper truck was stationary on lane 1 of the 5 lanes of the Pan Island Expressway towards the direction of Tuas, due to a burst tyre. A while later, the Deceased was travelling on lane 3 of the 5 lanes when he suddenly veered towards lane 1 and collided onto the left rear portion of the Involved Party's tipper truck. As a result of the accident, the Deceased sustained multiple injuries and succumbed to his injuries. He was pronounced dead at scene at 2 p.m., by the attending paramedic, SSgt Asyraf.
