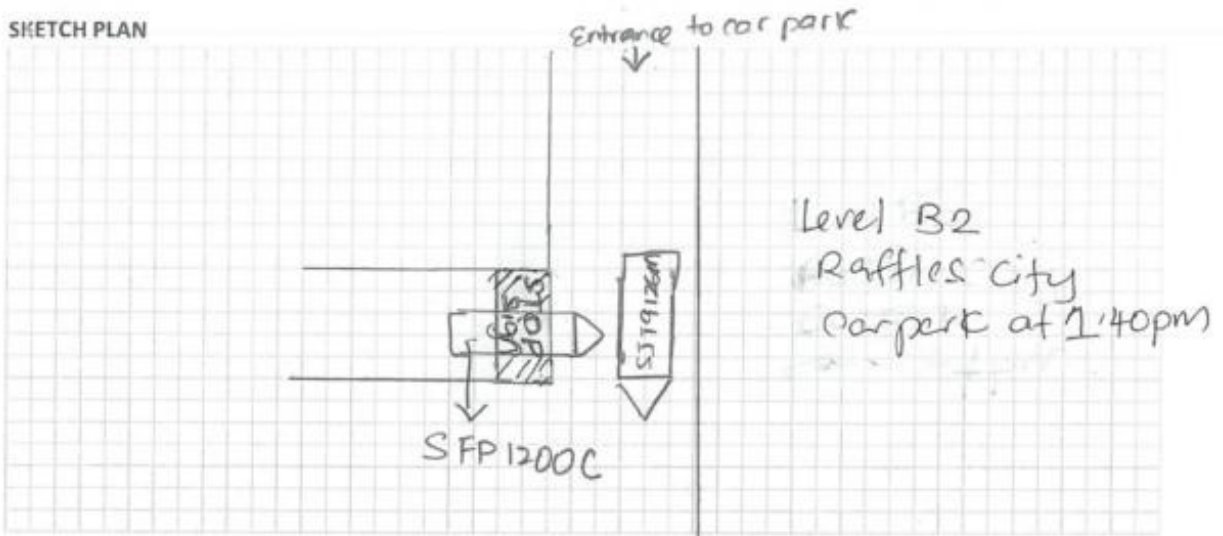





### Sketch Plan #3

I am the owner and driver of Vehicle No. SJT9126M. I am filing this insurance claim against BMW Vehicle No. SFP1200C.

 The accident took place at Level B2 of Raffles City carpark, near Row E-02, at 1.42 pm on 27 November 2019. I had just exited the ramp from B1 after having slowed down my car considerably because of the hump at the bottom of the ramp. Vehicle No. SFP1200C driven by Ng Chee Kien exited the side road on my right without stopping at the bold "STOP" sign and collided into my car. Besides the "STOP" sign, there was an overhead lighted sign visibly warning drivers exiting the side road to "Look Out for Vehicles From the Left". He did not heed this warning sign too causing this accident.

My car suffered extensive damages on the right as a result of the accident. There were some scratches on the front bumper of SFP1200C and its front number plate was dislodged. Mr Ng Chee Kien offered to compensate me on a private settlement basis but I refused the offer because of the extensive damage to my car.
