I was driving rented van GBH2328B into Tampines Ave 12 from TPE, I saw a range of pylons or cones place on the road covering part of the road leading towards Tampines Ave 9. I slowed down almost to 20 km/h looking to my right for on coming vehicles from Pasir Ris while taking note of a Silver Cab taxi bearing the registration of SHD1016H which I kept a distance. While concentrating on the on coming traffic i did not notice of a motorbike in front of me on my right. When i found it was safe to move on I accidentally hit the motorbike with the registration no.FBE3129 right in front of my van and hit it's back and topple it down. The rider/owner Mr.Mohamad Alfian Bin Puhari holder of I/C no.S8341162G was pin down by his bike. Without any hesitations I assisted him to the side road and on coming biker assisted me to call for SCDF ambulance with the thought of ensuring he got the treatment for his injuries. His bike has accidentally move infront due to the slight impact and graze the right side of the Silver Cab Taxi lower bumper and resulted with a small scar. A moment later SCDF ambulance came attended to Mr.Mohd Alfian. Later on 3 Traffic Police officer came and handled the accident matter.
