## Brief Details.

My name is MUHAMMAD FIRDAUS BIN MOHAMED RASHID and I am the sub rider of my vehicle FBJ5873M. I am using the vehicle for Food Panda delivery business. On 9/10/2019 at about 1330 h was riding on the extreme left lane of North Bridge Road. As I was approaching the junction of North Bridge Road and Middle Road, a taxi vehicle SHC7920M which was travelling on the lane on my rig tried making an illegal left turn into Middle Road, even though the lane the taxi was on was not allow make that turn. As a result, I collided into the left of the taxi head on as I intended to travel straight of lane I was on. Both our vehicles then stopped and the taxi driver alighted.
