### FACTS OF CASE:

I am the above mentioned person.  
The bike FBS 5873M is registered under the name of my friend. I am the main driver. I have a valid class 2A and 2B driving licence which was obtained in 2016. I am currently working as a full-time delivery rider with Food Panda and Grab. I would use this bike for delivery for orders received by Food Panda and Grab eats. The bike was purchased second hand around middle of 2018. Currently there is still outstanding loan and I am paying \$200 monthly to service the loan. For about 18 months left.

On 09/10/2019 @ 1330hr, I was on my way home after completing a delivery. I cannot recall where I had come from. I was travelling in the between left lane of North Bridge Rd towards the direction of Clark Quay. The weather was fine and road surface was dry. At the junction of North Bridge Rd and Middle Rd, I proceeded in my lane straight. Suddenly, a citycab taxi entered into my lane from the lane on my right. This taxi was intending to make a left turn onto Middle Rd. I was not able to react in time due to the sudden lane change of the taxi. The front

STATEMENT

My moped bike hit onto the left front passenger door area of the taxi. The momentum of my bike resulted in contact ~~at~~ along the right side of my bike and the taxi. My bike landed in front of taxi. I sustain injuries along my right body. A passing ambulance stopped and tended to my injuries. I called for Traffic Police. I was conveyed to Raffles Hospital and was discharged on the same day. I was given 5 days MC.

While at the scene, I took some photos. A passing named Bobby approached and offered to be my witness, saying that he saw what happened. He provided his contact number 9066 5858.

I subsequently received a letter from Traffic Police informing that action has been taken against the driver of the taxi for causing the accident.

I wish to state I lost my driving license some time ago and did not go to make a physical copy. I lodged a Police report regarding the loss of my driving license on 30/12/2019. I do not recall how I had lost my driving license. The city cab taxi involved in the accident was SHC 7920M.
