Brief Details.

On 30/11/19 at about 2015hrs, I was driving my car (SKR8678E) along PIE towards Changi Airport before Bedok North exit, the vehicles in front of me came to stop as such I also stop my vehicle. About few seconds later, suddenly the second car (SJD9785U) collided onto the rear of my car. Both of us got down from our car to take a look on the accident. When I came out from my car, I saw there was a third car (SJD5364L) behind the second car which had collided onto my vehicle. I assume that that was a chain accident involving another 2 vehicles. I asked if anyone was injured, the driver of the 2nd car said he was calling the ambulance as his passenger was carrying a baby during the accident. The 2nd car driver also called for police assistance while waiting for the ambulance.

On the arrival of traffic police, the officer took our particulars and also ask for the story of the accident. Upon the arrival the of ambulance, the paramedics made a check on the 2nd car driver passenger and also the passenger of my car as the female passenger that was in my car felt pain on the her neck due to the accident. As such the paramedics called for another ambulance down. After the paramedics made a check both my female passenger and the 2nd car passenger was conveyed by ambulance to hospital. I
