I WAS DRIVING MY VEHICLE AND JUST PASSED TAMPINES AVE 12 EXIT ALONG TPE TOWARDS SLE. WHEN THE VEHICLE OF CAR PLATE (SLE2837X) SUDDENLY CAME FROM BEHIND AND TRIED TO OVERTAKE ME. AS A RESULT, MY CAR'S REAR RIGHT SIDE WAS HIT BY THE LEFT FRONT SIDE OF THE CAR (SLE2837X) UPON KNOWING THE COLLISION, I IMMEDIATELY STOPPED MY VEHICLE AND TRIED TO INVESTIGATE THE DAMAGES CAUSED. THE DRIVER, MR WOO MAN CHENG INITIALLY REFUSED TO PROVIDE HIS IC TO ME AS I REQUESTED TO CHANGE OF PARTICULARS UNTIL I TOLD HIM THAT I WOULD REPORT TO POLICE IF HE REFUSED TO DO SO. AS A RESULT, DRIVER'S PARTICULARS WERE EXCHANGED AND BOTH CARS LEFT THE ACCIDENT SPOT.

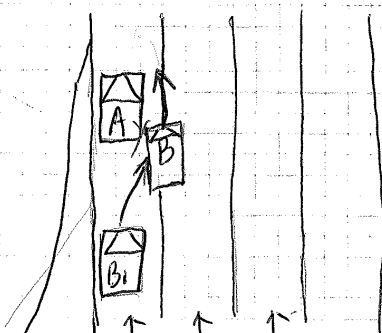


