Circumstances of Accident

An officer called my mother (policy and car owner) on Wednesday night December 3rd saying that the car was involved in an accident. I was the one in charge of the car and she contacted me to call the officer back - Esmond Tan IO from Ubi Police (contact: 65472077). He didn't give many details but asked if I was in an accident as someone had reported it. He said my car was allegedly in an accident in Maju Avenue in Serangoon Gardens. I told him I was not. There was no accident or anyone who was hurt. He asked for photos of the car which I took and sent him. Pictures are attached. He asked me to make a police report the next day as someone said I had hit his car. There was no new damage to my car. All scratches and scrapes are old. I made the police report the next day (T/20191204/2041) confirming the same details. No additional info has been provided but he police.

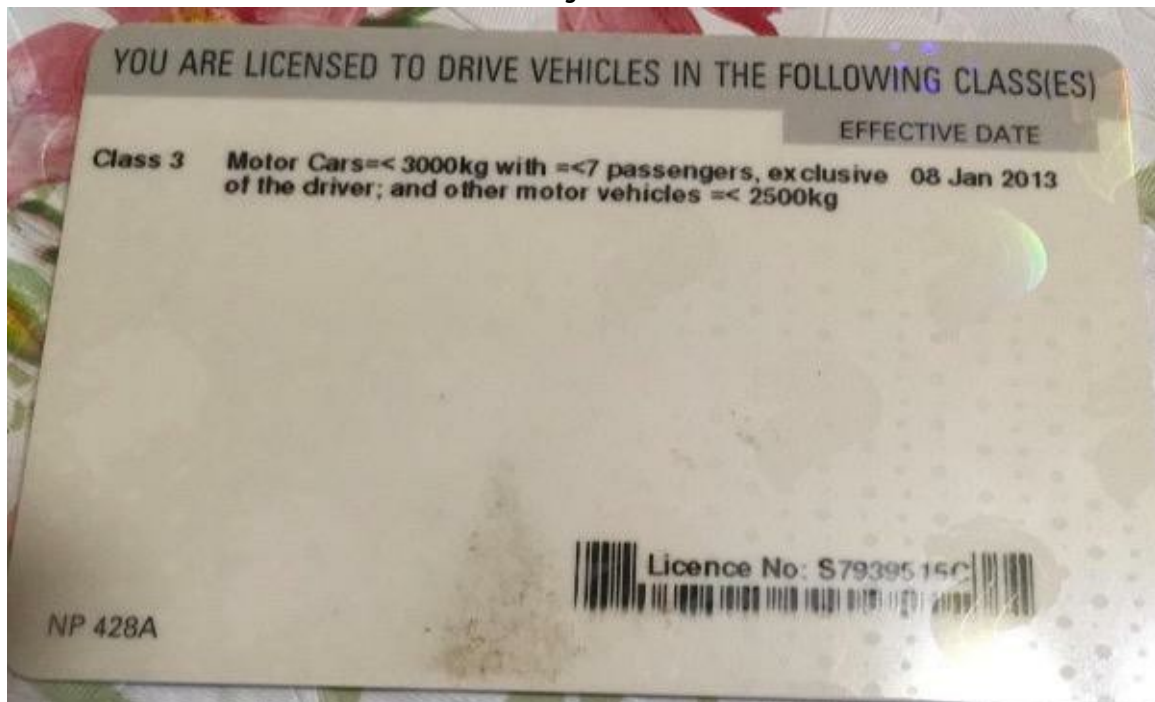
