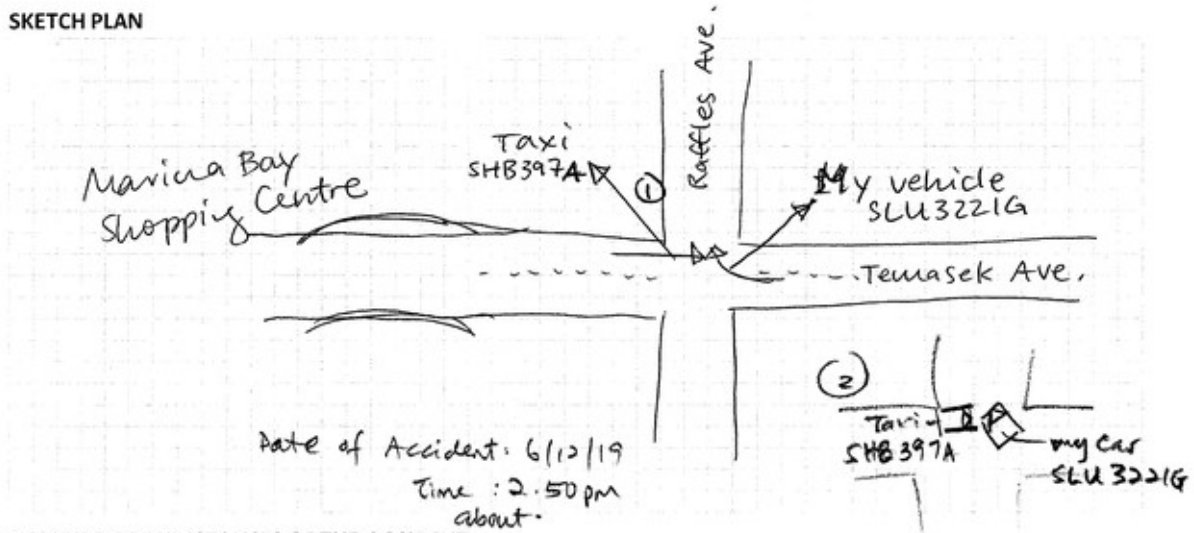

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving along Temasek Ave. heading the direction of Marina Bay, and turning right at the intersection of Raffles Ave. The taxi was coming from the opposite direction, crossing the intersection, intending to go straight on to Temasek Ave.

We were colliding in the middle of the intersection.
