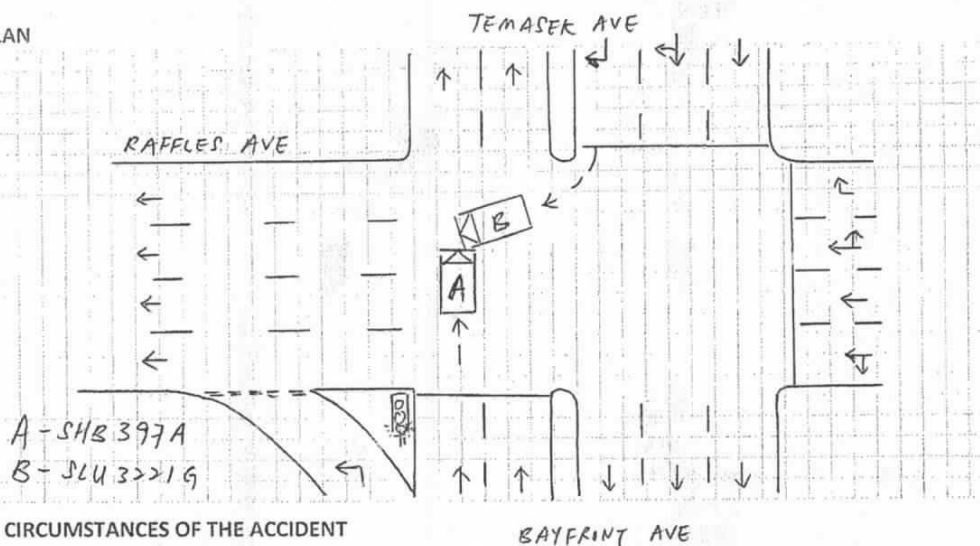

SKETCH PLAN



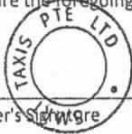
