

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 01/12/2019 at about 2028 hrs at Junction of Rangoon Road and Race Course Road. I was travelling on the extreme Right lane along Rangoon Road and when coming towards the above mentioned junction, I came to a stop while giving way to the main traffic before I make a Right turn into Race Course Road. When the traffic was cleared as such I proceed my Right turn into Race Course Road. While doing so a Vehicle (B) making a Right turn from Race Course Road towards Rangoon Road without stopping and without proper lookout hence collided onto my Right Rear Portion of my Vehicle (A) causing damages to my vehicle.
