CONTINUATION OF REPORT

Brief Details.

On the 10/12/2019 at about 1300hrs, I was driving my pickup truck (NCS7280) together with my other 2 passengers and was travelling along Sungei Kadut Street 1. I observed that there is another vehicle (GX9348D) coming out from Sungei Kadut Street 4 (GX9348D) and was approaching at a fast speed. As it was my right of way, I assume that the other vehicle would slow down at the stop line. However it did not slow down and it came out of Sungei Kadut Street 4. Right at the junction, I crashed into the right side of the driver's door and both of us came down to check on the damages. The driver was fine and did not complain of any pain. There is no police or paramedics that attended to the scene. However I felt pain on the right side of my back area and as for my other 2 passengers, one felt pain on his right chest area and one felt pain on his left shoulder area. The damages to the other party vehicle is serious as I crashed into his driver seat door and it is badly dented. The front bonnet of my vehicle is damaged too. I wish to state that due to the accident, My 2 passengers as well as myself got a 2 days MC from the doctor due to the injuries sustained. I wish to state that there is no government property damaged.

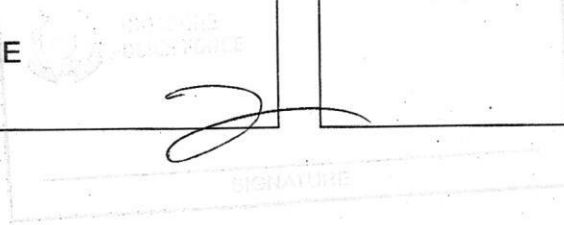
