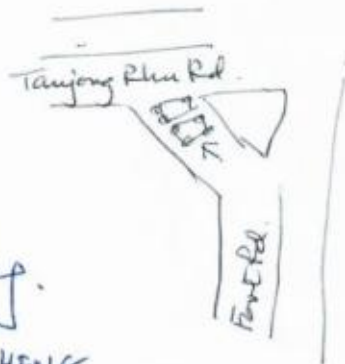
Issue date 10 Aug. 2004
