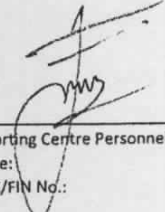

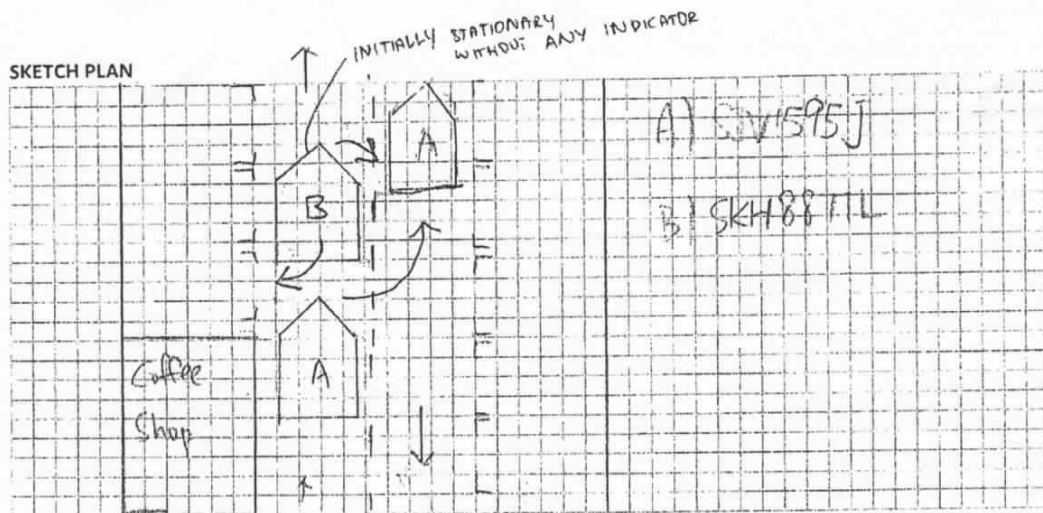

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 3rd December 2019 at about 20:16 PM, I was about to drop off my rider at 28 Jln Bukit Merah Lift lobby. But while I entered the car park gantry, the car ahead was stationary and it was ~~dis~~ disrupting the traffic flow into the car park. I flashed my head light to the front car and then it started to move forward slightly.

Seeing that the car ahead again stop, I decided to overtake on the right side. But while I overtake and passed the front car slightly, the front car started to reverse and turn backward towards its left. Such manoeuvre caused the front car to hit on my left front door creating a dent and scratches.

Front Driver is an Indian old man and he refused to exchange contact or particular. The car park is brightly lighted.
