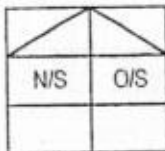

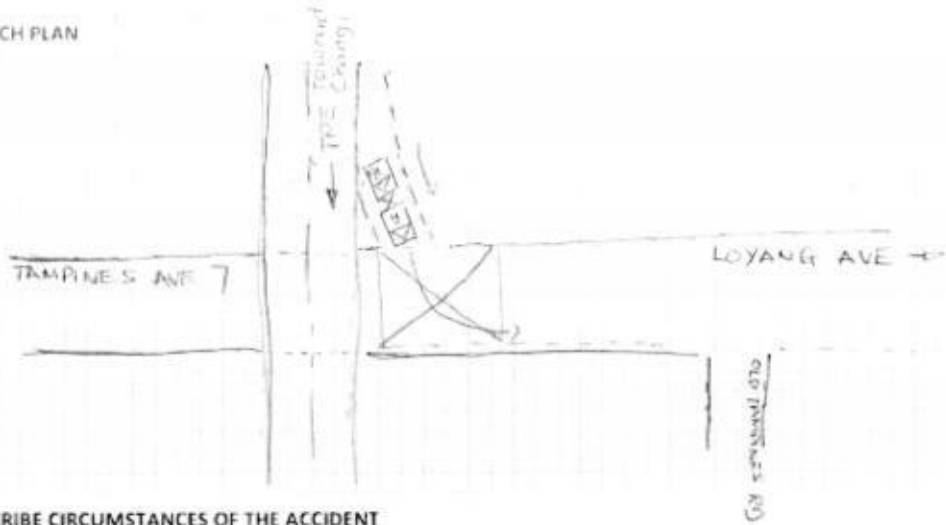

Brief Details.

On 08/12/2019 at about 1240hrs, I was driving from TPE towards Loyang Avenue. At the slip road from the TPE exit to Loyang Avenue, I stopped at the give way line to look-out and give way to oncoming traffic along Loyang Avenue. Suddenly, I felt an impact from the rear and the impact caused my vehicle to move forward into Tampines Avenue 7 where there were vehicles oncoming.

I then moved towards the right to stop my vehicle and wait for the other party to meet up with me. However, the other party drove off without stopping.

There is a camera installed at the rear and front of my vehicle which captured the accident. From the video footage, my brother managed to obtain the vehicle registration number of the other party involved.

At the time of the accident, my passengers and I were not injured.

As a result of the accident, the rear bumper of my vehicle and the rear boot cover of my vehicle was damaged.

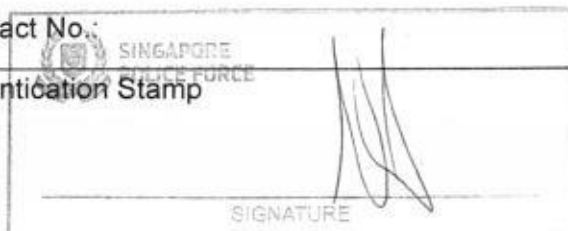

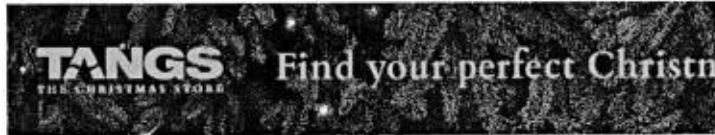

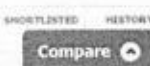
