SKETCH PLAN



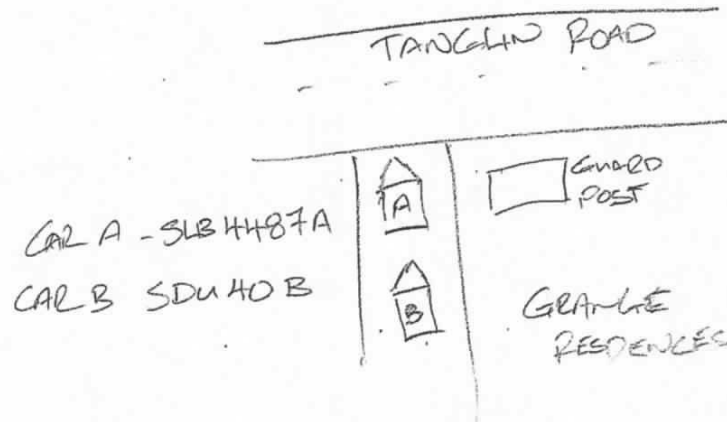
