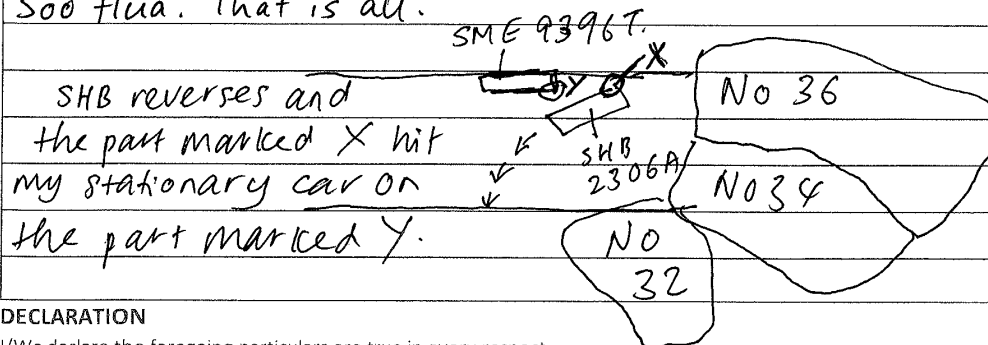

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Driver of taxi number SHB 2306A came to my house at 7.30pm, 5 December 2019. He informed me that he came to pick up my neighbours at 5.30am, 5 Dec 2019, from their house, No. 32 and when he reversed, his front side scratched the side of my car including the headlamp. He said he had made a police report and was accused of being guilty of a hit-and-run. He said he had no intention of evading responsibility. I told him we should let our insurance companies handle the matter. At the time of the accident, my car was stationary and was parked at the proper parking area by the roadside and as close to the kerb as possible. Nobody else apart from the taxi driver and his passengers was around at the time. He let me take a photograph of his LTA vocational licence No S0026709J. His name is Gui Soo Hua. That is all.
