


I understand, acknowledge, agree and consent that:

GIA/MS Sketch Plan Form V3

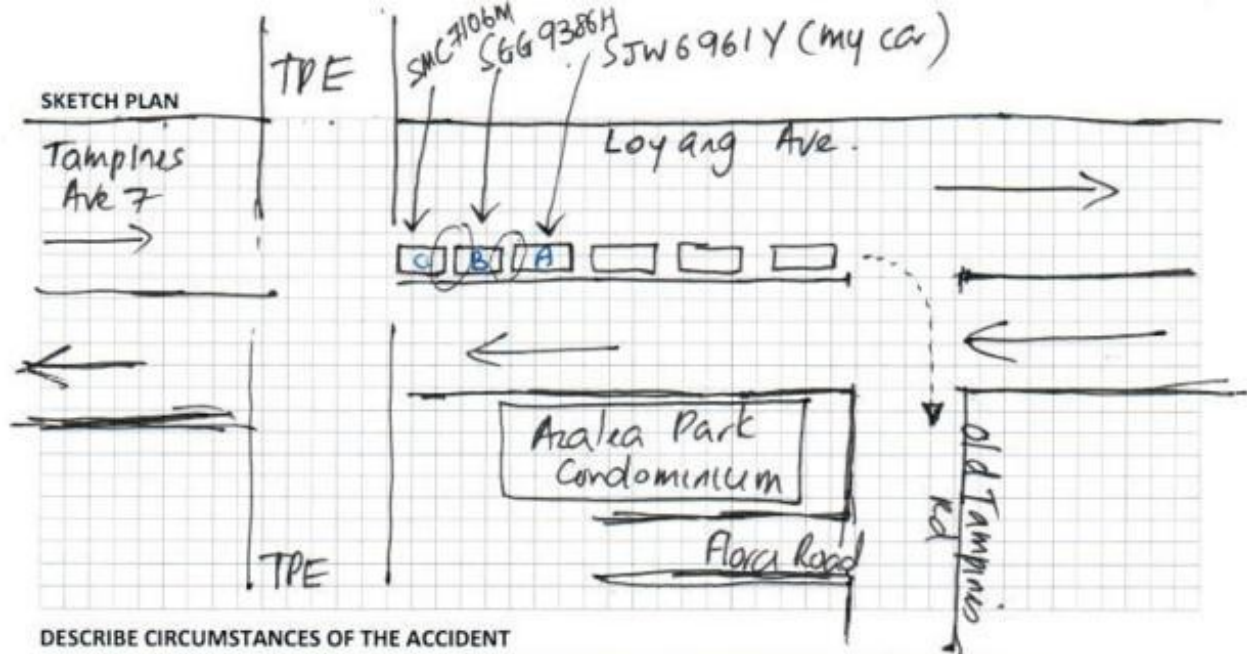
