Brief Details.

On the 04/12/19 at about 0945hrs, I parked my vehicle bearing registration number SMC688X, at the open space carpark of Blk 684 Hougang Ave 8, carpark no. HGHG64, in lot no. 19. Everything was in order.

When I came back at about 1020hrs, I discovered damages on the front portion of my vehicle. My front bumper was dislodged and there were scratches.

I viewed my front in-car camera, and discovered that a one white colour vehicle bearing registration number SJU1999H had hit onto my vehicle. The said vehicle which was parked in lot no. 18, parked directly beside my vehicle, was exiting out of the said lot, when the left side of the said vehicle hit onto the front right portion of my vehicle.

The said vehicle stopped momentarily and moved off to the other side of the said carpark. Shortly later, one lady clad in a turquoise top, believed to be the driver, came back and was seen assessing the damages on my vehicle. She did not leave any note behind and left thereafter.

I wish to state that my in-car camera also captured one male passerby who had witnessed the collision. He had snapped a photo of the said vehicle but also did not leave any note behind.

I also wish to state that the said vehicle was already there when I parked my vehicle earlier.
