Authorisation(s)

The Customer hereby authorises Gold Autoworks to carry out repairs on the Vehicle. The Customer further authorises Gold Autoworks to move, test drive, or otherwise operate the Vehicle for the purposes of repairing and/or determining the Vehicle's functionality and safety.

The Customer acknowledges that any data or documentation pertaining to the damage analysis or repair of the Vehicle collected and/or produced by Gold Autoworks is for the sole purpose of carrying out repairs on the Vehicle, and the Customer hereby authorises Gold Autoworks to utilise and/or disclose such data or documentation in furtherance of such purpose.

The Customer hereby represents to Gold Autoworks that the Customer has authority and capacity to contract with Gold Autoworks for the repair of the Vehicle. Payment



The Customer hereby agrees to pay Gold Autoworks for all the repairs to the Vehicle as provided for under such analysis of damage, survey report, expected repair cost, and/or repair plan carried out by Gold Autoworks and/or its agents (the "Damage Analysis"). The Customer further agrees to bear the cost of the Damage Analysis.

All payments due to be made by the Customer to Gold Autoworks shall be done so within seven (7) days from the Customer's receipt of an invoice issued by Gold Autoworks.

Gold Autoworks shall provide a copy of the Damage Analysis to the Customer for his/her approval prior to carrying out the repairs and the same shall be incorporated herein by reference.

Additional Damage

Additional damage may be discovered and the need for additional repairs not included on the Damage Analysis may become apparent during the course of repairs. In that event, Gold Autoworks shall notify the Customer of the additional repairs and the expected cost thereof.

Gold Autoworks may provide a supplemental Damage Analysis or may incorporate the additional repairs into a revised version of the initial Damage Analysis.

No services beyond those described in the initial Damage Analysis will be performed by Gold Autoworks without the Customer's prior written approval.

Parts

Gold Autoworks shall utilise new original equipment manufacturer ("OEM") parts when performing repairs., subject to availability of stock.

In the event that the Customer elects to utilise non-OEM parts and Gold Autoworks determines that the use of such parts do not affect the safety or performance of the Vehicle, Gold Autoworks shall not be held liable for any decrease in value of the Vehicle and/or any breach or violation of any hire-purchase agreement(s) between the Customer and the relevant third party finance company and/or any breach of the Vehicle's manufacturer's warranties.



Lien

The Customer acknowledges that Gold Autoworks shall have a lien over the Vehicle for any and all amounts due and payable under this Agreement until such amounts are paid in full.

The Customer further agrees to indemnify Gold Autoworks against any and all costs and expenses, including reasonable legal costs, incurred in relation to any demand or claim or lawsuit initiated and/or commenced by Gold Autoworks for the recovery of any amount due and payable under this Agreement.

Warranty

Gold Autoworks hereby provides to the Customer a limited warranty extending only to the scope of repairs performed under the terms of this Agreement.

The aforesaid warranty shall subsist for a term of six (6) months from the date of completion of the repairs.

During the term of the aforesaid warranty, Gold Autoworks shall at its own cost and expense, correct any defects in workmanship relating to the repairs performed under this Agreement.

For the avoidance of doubt, the aforesaid warranty covers labour only, and does not extend to any parts used for the repairs. In addition, the aforesaid warranty does not cover any defects that arise from wear and tear.

Entire Agreement

This Agreement, and any documents incorporated by reference, constitutes the entire agreement and understanding between the parties relating to the matters contemplated herein and supersedes all prior agreements (if any and whether in writing or not) between the parties in relation to such matters.

This Agreement cannot be modified orally and may only be altered in writing by a document signed by both parties.



Severability

Each provision of this Agreement is severable and distinct from the others. If any provision of this Agreement (wholly or in part) is or becomes illegal, invalid or unenforceable, it will not affect the legality, validity or enforceability of any other provision of this Agreement.

If any provision of this Agreement (wholly or in part) is or becomes illegal, invalid or unenforceable but would otherwise be legal, valid and enforceable if the provision or some part of the provision was deleted or modified, the provision or part of the provision in question shall apply with such deletions and modifications as may be necessary to make it legal, valid and enforceable.

Right of Third Parties

Unless expressly provided to the contrary in this Agreement, a person who is not a party to this Agreement has no right under the Contracts (Right of Third Parties) Act (Cap. 53B) to enforce or enjoy the benefit of any term of this Agreement.
