Describe Circumstance of the Accident.


ON 12/12/2019 @ 1930 HRS, I WAS DRIVING MY TAXI ( SHC 6418 D ) – TRAVELLING ALONG SIMS AVE EAST IN LANE 3.

WHILE I WAS MOVING STRAIGHT AHEAD – SUDDENLY I FELT AN IMPACT FROM MY RIGHT.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B ( SHA 1020 K – COMFORT TAXI/HY IONIQ ) WHICH WAS ON LANE 2 – HAD ENCROACHED & COLLIDED ONTO THE RIGHT PORTION OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE RIGHT REAR PORTION & VEHICLE B HAD DAMAGES ON THE LEFT FRONT PORTION.
