May I seek your assistance to perform a detailed mechanical inspection of the **3 vehicles** below on an **urgent** basis, please.

- a) Case IAFP-IB-20191202 - Mechanical Inspection of Motor Taxi, SHB1982D (TP/IP/74669/2019)
- b) Case IAFP-IB-20191202 - Mechanical Inspection of Motor Lorry, YP2418K (TP/IP/74669/2019)
- c) Case IAFP-IB-20191202 - Mechanical Inspection of Motor Scooter, FBG9070C (TP/IP/74669/2019)

On 2 December 2019 (Monday) at about 7.37 p.m., the 1st Involved Party was travelling straight along Ayer Rajah Expressway towards the direction of Tuas on lane 2 of the 4-lanes road while the 2nd Involved Party was travelling straight on lane 3, abreast to the 1st Involved Party. A while later, the Deceased who was travelling directly behind of both Involved Parties, collided into the rear portions of both vehicles. Unsure which vehicle that the Deceased collided into, first. As a result of the accident, the Deceased sustained head injury and was reported to be unconscious hence he was conveyed to National University Hospital by an ambulance. However, upon the Deceased's arrival in the said hospital, he suffered a traumatic arrest. The Deceased subsequently succumbed to his injuries and was pronounced dead on the same day at 8.57 p.m. by Dr Gene in National University Hospital.
