Brief Details.

On the 04/04/2014 at about 1520hrs, I was driving my taxi SHC5209Y, with 3 passenger, travelling along West Coast Road, at Jalan Buroh roundabout. I was in the 2nd lane in the middle of the roundabout, towards West Coast Highway, city direction.

While in the middle of the 2nd lane a vehicle SGM8938R from 3rd lane tried to cut into my lane. However he did not anticipate and the front right of his vehicle hit onto my left front of my taxi. Both of our vehicle came to a stop. Unfortunately another vehicle SGY5065R from the 1st lane hit onto the rear of my taxi. 3 of my passengers were injured, due to the impact from the driver side, I suffered some pain on my neck, as such I went to see a doctor and was given 5 days of MC.

I am not sure if there were any CCTV installed around the premises. I am lodging this report so that the traffic police can assist me in investigating this matter.
