## Date of accident on 4/4/2014 involving vehicles SGM 8938R & SHC 5209Y

We refer to the below email.

Third Party reported that he was travelling on the 2<sup>nd</sup> lane along West Coast Highway towards City. While travelling, the insured vehicle from 3<sup>rd</sup> lane tried to cut into his lane and hit onto the left front of taxi. Then another vehicle (SGY 5065R) came from the the 1<sup>st</sup> lane and collided into the rear portion of vehicle. Please find the attached statement.

The insured reported that he was travelling along Jalan Buroh on the extreme left lane of 3 lanes. After West Coast Highway, our of a sudden, he felt a strong impact from rear right portion of vehicle. After he alighted, it was 3 vehicles involved in the accident as a chain collision. Please see attached OI's statement.

We did call OID to verify the nature of accident. OID mentioned that he was travelling straight all the way and was hit by TP's from the  $2^{nd}$  lane. Total of 3 vehicles chain collision.
