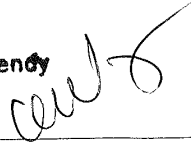

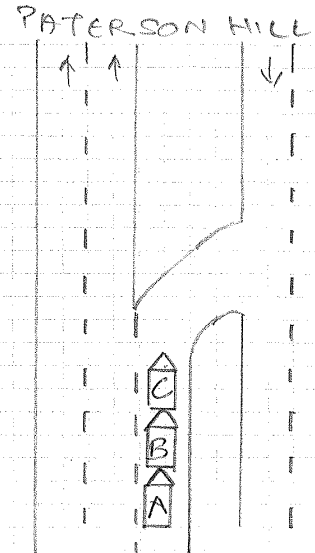
Sketch Plan Pg. 2
