**Brief Details.**

On 19/12/2019 at about 8:20am, I parked my vehicle (SGB9029R) at the open space carpark at Blk 552 Pasir Ris St 51 at carpark lot number 335. I locked and secured my vehicle and my vehicle was intact with no damages. I saw that beside my vehicle on the driver side at carpark lot 334 was a lorry which belonged to a bread company probably delivering goods to the Mini-mart shop nearby. On the passenger side was another car. After which, I went up back home.

At about 9:10am, my daughter came back down to retrieve my car to drive off to work. However, when she arrived she saw that the front right portion of the vehicle was badly damaged. The right front wheel was turned in, the area near the wheel was badly dented in creating a hole, and the front bumper was already shifted and slightly dislodged. My vehicle had also shifted to the left side. My daughter thus called me and I rushed down.

I was not sure how my vehicle got damaged so badly but I suspect that it might be caused by the lorry which was parked on the right side of my vehicle at lot number 334. My vehicle has an onboard camera but I currently still trying to retrieve the footage from it. I do not have any conflicts with any of my neighbours. I believe that the Mini-mart owner might be able to get the company which the lorry belongs to.
