

On 19th December 2019, at about 0825 hrs, I was driving vehicle no SLU7866U, inside HDB Hub basement 1 carpark, located at 480 Lorong 6 Toa Payoh (310480). I was driving around searching for an available lot to park my vehicle.

I was travelling along lane no 5 when I approached a junction. As I was nearing the junction, I checked on my right side and confirmed that there were no approaching vehicle before deciding to drive straight. When I just passed the stop line mark, a vehicle from my right, SGG 90821, headed straight towards me and hit my front right bumper. I was not able to avoid the collision due to the space availability in the packed car park. I stop my vehicle immediately and checked the damages.




