

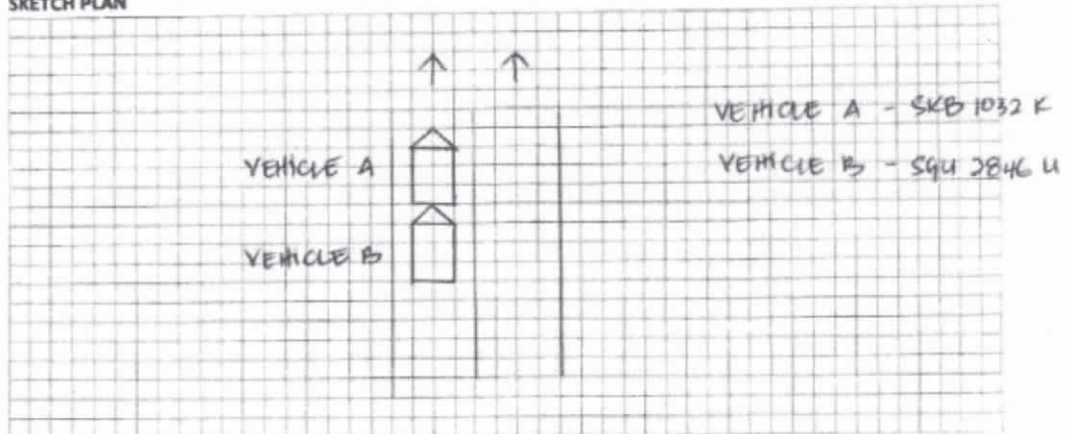

NOTICE OF REPORTING

This is to confirm that SUHAILA BINTE MOHAMED AZMI, NRIC: S7722259F, HP: 92955455, has reported to the Police a non injury traffic accident which occurred along Woodlands Causeway, right after Woodlands Checkpoint, on 17/12/2019 at 1400hrs involving the following vehicles;

- 1) SKB1032K (complainant's involved vehicle)
- 2) SGU2846U (Blue, Suzuki Swift)

On the above-mentioned date and time, complainant was driving along the above-mentioned location, complainant just passed the Checkpoint area (CIQ) and Woodlands Checkpoint and was heading into Johor Bharu via Woodlands Causeway. Complainant was on the left most lane of the road during that period. Complainant also had one passenger with her during that period, "Mohamad Zulhilmi Bin Ab Ghani" (M'sia IC: 920511065765) HP: 96853926.

Complainant informed that the traffic was a stand-still and she was awaiting to move forward, she was safely stopped behind the vehicle in front of her. Complainant was then suddenly knocked by the other vehicle (SGU2846U) from the rear without warning. The impact was quite strong but complainant's vehicle did not collide with the vehicle in front.

Complainant and her passenger were not injured after the collision, complainant then spoke to the other driver who informed that he and his passenger were not injured as well.

Complainant wanted to settle the accident privately with the other driver and took down his particulars and contact number, complainant and the other driver thus went their separate ways. No police or ambulance attended to complainant, there was not government property damage.

Damages on V1 (Complainant's vehicle) are as follows:
Middle of the rear bumper, license plate dented inwards. Right side of rear bumper dislodged. Left side of rear bumper dented inwards.
