SKETCH PLAN



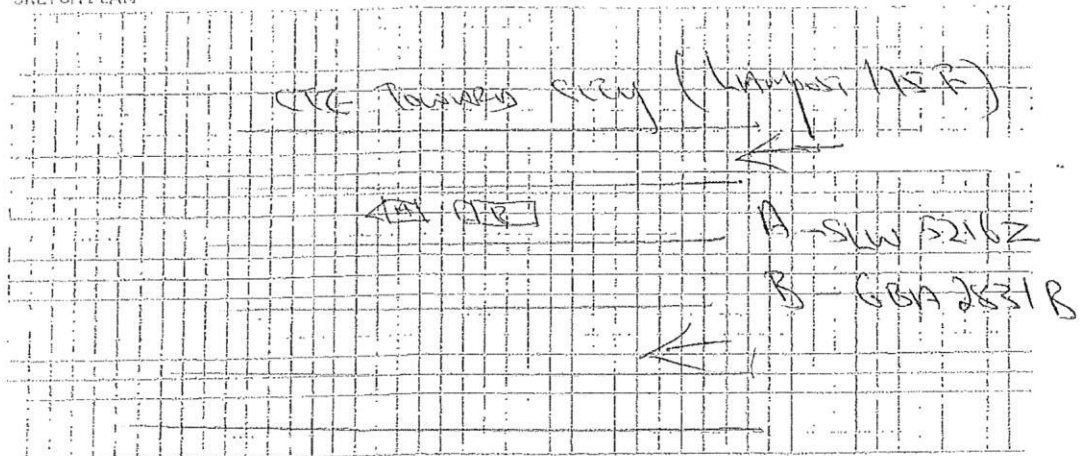
