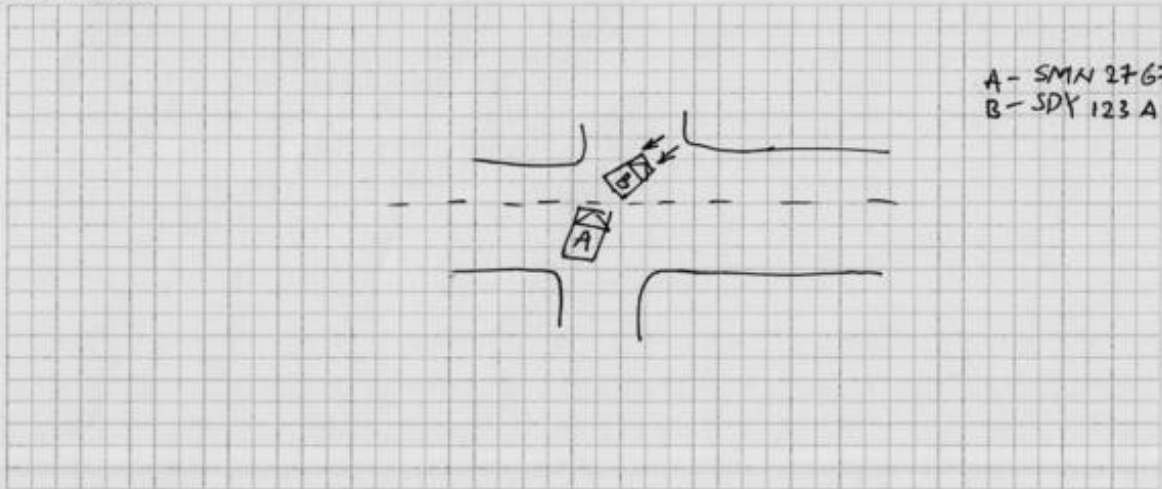

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At 20:38 of Dec 24th, 2019, I was driving out of the Quayside Condo's carpark to discover there was a black Mercedes E250 trying to enter an opposite condominium. Due to suspicious movement of the vehicle, (Break light going on & off, as well as extensive discussion with the guard at the condo), I waited a while until the other car started to back into the main street in the midst of heavy traffic jam on the road. When the car finally finished backing up, just enough to make his way onto the main road, he started moving forward; therefore, I followed to join the main road, since there were no cars blocking the road or making way. However, the car suddenly stopped and started backing up again without checking his mirror. And even though I had made a stop already and tried to honk/back out, I was already late by the time he backed into my stalled vehicle to make significant scratches on my bumper, head light as well as radiator grill. All described above are well-recorded in the in-car camera as a proof.
