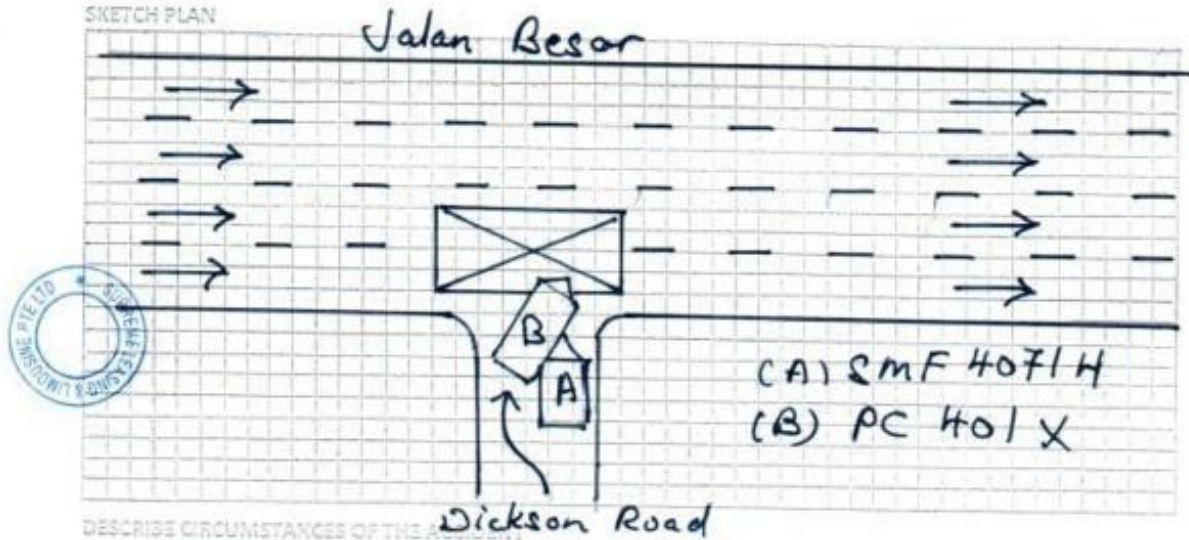

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 27/12/2019 at about 1040 hrs at Junction of Dickson Road and Jalan Besar. Suddenly a Vehicle (B) from my Rear overtook my vehicle (A) from the left and made a sharp Right turn into Jalan Besar without proper lookout and hence collided onto my Left Front Portion of my Vehicle (A) causing damages to my vehicle. I wish to state that during the impact my vehicle was still at stationary position.

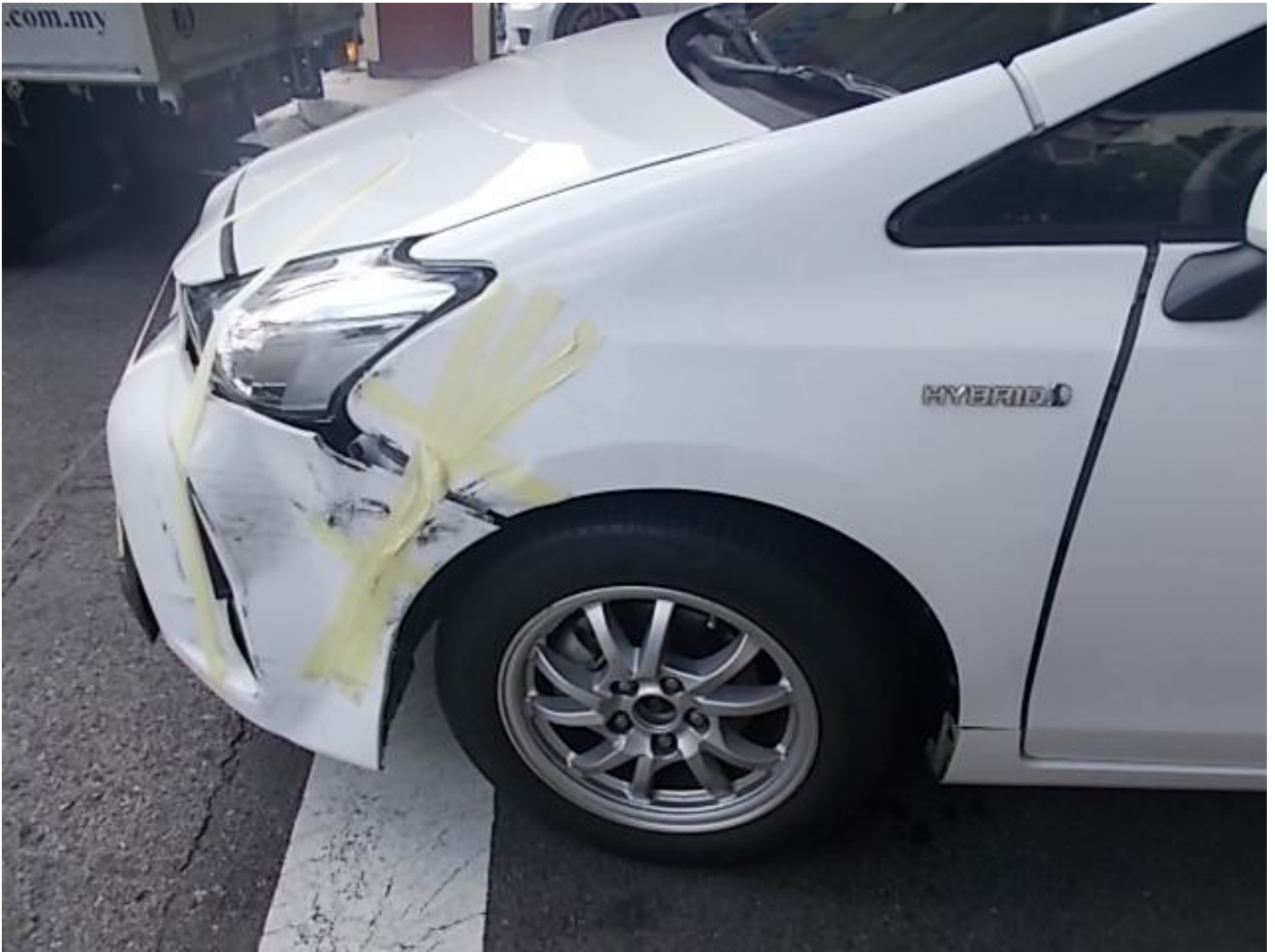
