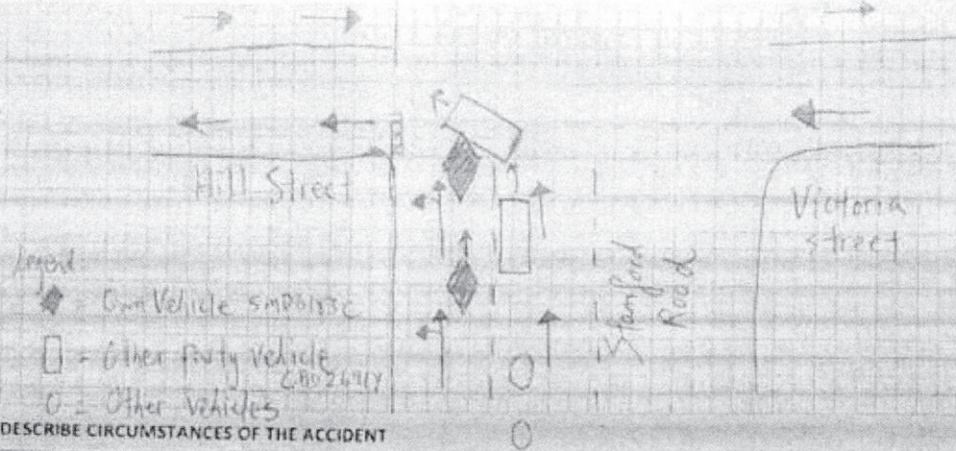


Accident Sketch Plan

SKETCH PLAN



On 29 Dec 2019, 14:55 hrs, I was driving along Stamford Road on the leftmost lane, about to continue straight at 61km/h towards Fort Canning Link at the traffic light junction that intersects Hill Street/Victoria Street.

The Other Party Vehicle (GBD2691Y), on my right then suddenly and without indicating his signal light, he turned left to go into Hill Street and collided with my vehicle front left side.

Damages to Own Vehicle:

- Front right headlight cracked, broken
- Front right bumper and under damaged due impact from other party vehicle
- Bonnet cover dented due impact
- Front Right hand side car body dented as well as front right wheel rim
- Scrapped abrasion
- Left front wheel rim
- Scrapped abrasion due impact against road kerb


