From the lying position of your insured's vehicle, it is clear that he has emerged from the stop line. The accident would not have occurred if your insured had remained stationary behind the stop line.

The fact that your principal has waived their subrogated claim (please refer to the attached email of 15/12/17 from our insurer) proved that the case is in our driver's favour based on Bola 9c.

Please review the matter.

If your principal is still maintaining their rejection, we will escalate the matter to GIA together with the proof for their adjudication.
