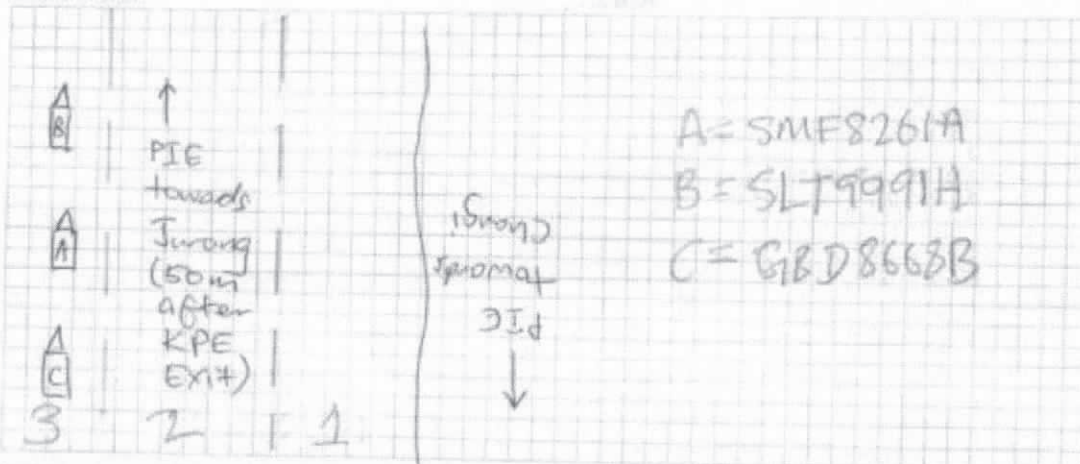

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

About 50m after KPE exit, on PIE towards Jurong, a silver Honda Shuttle (SLT 9991H) started to slow down. I also came to a stop. About 3 seconds later, there was a loud braking sound and we felt a vehicle slam into my car. Coming out of my car, I saw it was a goods delivery van (GBD8668B).

The back of my car was badly damaged and an EMBL vehicle & LTA marshal soon arrived. After taking pictures of the ICo & exchanging contact number among the 3 parties, EMBL towed my car to Tan Tay Poyoh stadium. The other 5 passengers in my car took a cab to a clinic for doctor checkup and 3 passengers were advised to go to Changi Hospital's A&E for X-ray.

My insurer, Direct Asia, sent a tow truck from Efficient Towing to bring the damaged car to Automotive Repair Centre. I contacted Raymond, manager of ARC & came down on Monday to discuss repair.
